| <ul style="list-style-type: none"> Must be resident of the District, a freeholder, and a qualified elector at the time of such election or appointment and he shall be more than 21 years of age. Cannot hold another elected or appointed public office of honor, trust or profit. A person holding another public office of honor, trust or profit who seeks to be appointed or elected a director must vacate the first office. Each member of the Board shall serve without compensation. Each member shall qualify by executing the constitutional Oath of Office and shall execute a good and sufficient bond for \$1,000 payable to the District conditioned upon the faithful performance of his duties, and the bonds shall be deposited with the depository of the bank of the District for safekeeping. Members shall have a commitment to the delivery of quality healthcare to the community and the fulfillment of the purpose of these bylaws. | August 24, 2026 |
